
Coastal Community Fishery Information Kaeb Thmei Community Fishery in Kampot Province (2017)

## **Community Fisheries Management Plan**

Kaeb Thmei Community Fishery has developed a three-year plan for 2017-2019. Although it is not considered as a community sustainable plan, it illustrates the activities that can contribute to the sustainable community development. The community fishery has a vision to ensure sustainable and equitable management of all fisheries resources that can contribute to poverty reduction in the community. To address illegal fishing, the community has mobilized supports from stakeholders, raised members' awareness of the law, and incorporated community plans into commune plans.

**Budget Plan:** Kaeb Thmei Community Fishery still relies on donations from its members. The budget collected from the community members and annual contribution is about 1,008,000 Riels. However, it is expected that the community will spend about 63,401,000 Riels to implement its action plan in the community's three-year plan. The community also plans to raise funds from civil society organizations (CSOs) and stakeholders to support their activities. This can be proved that the community is dependent.
