We predict our customers' needs and do everything in our power to satisfy them.

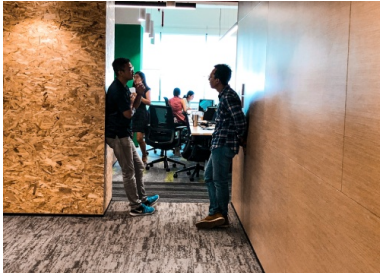
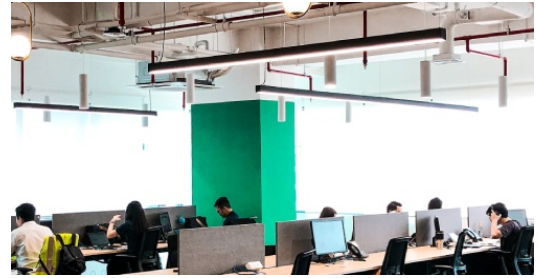

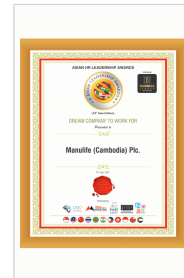
