Community Fisheries Management Plan

Community Fisheries Management Plan shall be prepared in accordance with Article 23 of the Prakas on Community Fisheries Guidelines of the Ministry of Agriculture, Forestry and Fishery (MAFF), based on the information related to the socio-economic status of the people, fisheries, and agriculture, the nature of the fishery involved in fishing, and community issues. The plan outlines specific action plans, such as fishing gear usage, fishing grounds improvement, conservation sites preparation, flooded forest management, aquaculture development, community budget development, fisheries co-management, additional businesses expanding, fishery product processing and marketing, safety fishing, and other plans.

Budget Plan: Preaek Tnoat Community Fishery has not had the independent budget yet because the community still depends on the donation from the community members and annual contribution.

Community's seagrass and mangrove management area

There are two areas where it is possible to create the management areas such as Thmor Tadaok and Thmor Donno. Thmor Tadaok rich in fishery resources including 20 hectares of mangrove forests and 750 hectares, about 375 hectares are the habitat for many species. In particular, there are about 750 hectares of mangrove forest rich of fish and aquatic species such as shrimp, crabs, squid, oysters, etc.

Fisheries Protection and Management Area

Fishery resources

Fisheries: 28 fish species, 29 aquatic animals, and 14 flooded forests and plants.

Estimated fish catch: Rastrelliger brachysoma 7,200kg, moolgarda seheli 3,350kg, siganus 135kg, horse crab 36,000kg, shrimp 1,810kg, snail 900kg, crab 590kg, and squid 2,700kg per year.
